Minutes for December 2, 2019

1. The meeting was called to order at 7:00 pm by President Tim Matthews with a declaration of a quorum and the Pledge of Allegiance.
2. Secretary Andrew Malcolm read the minutes from the last meeting; which were approved.
3. Vice President Jerome Slusarski reported that Doug Ewert's brother Jack passed away recently.
4. Treasurer Doug Olsen provided a detailed report on the income, expenses, checking and savings balances for the month. The club had an income of \$835.23 for the month and expenses of \$6498.12. There is \$1047.66 in a savings account and another \$24,220.71 in a checking account.
5. Range Officer Ron Brooks reported on some issues at the range.

- a. The new safety lights have been installed on the covered firing line. Please turn these lights on when going down range and during “Cease Fire” situations. Turning these lights off when you leave the range for the day would also be appreciated.
6. Membership Officer Dave Lawrence reported that there are 7 individuals on the waiting list.
7. Old Business
 - a. None
8. New Business
 - a. Nic Blaser made a motion to purchase six pepper popper targets made from AR55 steel for \$1590, including free shipping. Billie Baxter seconded the motion. After a brief discussion, the club voted to approve this purchase unanimously.
 - b. The club voted to approve the following members as officers for 2020.

President- Bill Suiter, Vice President- Nic Blaser, Secretary- Andrew Malcolm, Treasurer- Doug Olsen, Range Officer- Rich Adams and Membership Officer- Dave Lawrence.
 - c. There was a short discussion about splatter coming off of the falling plate target racks. A possible way of preventing splatter from leaving the bay, would be to install a shield above the racks. This solution will be discussed and explored by the Executive Committee. Until a more permanent solution can be developed, these targets will be moved to the south target shed bay which is well away from the rest of the range.



- d. Austin Keyes made a motion to add Bleed Kits to the first aid boxes at the range. The motion was seconded by Allen Keyes. Austin first presented his concerns regarding our first aid kits to the executive committee at their December 2019 meeting. In addition to purchasing and placing the kits at the range, he also suggested that all club officers and match directors take training on how to best use these new kits. The Executive Committee is looking into setting up training that could be offered to all members. This motion was tabled until the January 2020 meeting in order to notify all club members of the up-coming vote.
- e. Fred Brooks reported on a new law/rule enacted in Lincoln, Nebraska requiring all firearms to be unloaded and covered up while being transported in a vehicle.
- f. Bill Suiter announced that the club is looking for a new individual to take over working with the gun show dealers. This position requires someone to communicate with the dealers and recording table requests. Filling in the table map and greeting dealers on the Friday set up day is also part of this position. This person also works with Ag Park in setting show dates and making sure a current show contract is signed.
- The meeting adjourned with a motion from Charlie Quail and a second by Dick Vandenburg. 32 members, 1 guest were present.
